

Access Code Request Form



The access code line is restricted to verifiable mechanic/body shops. The mechanic/body shop must have access to an email or working fax for a code to be provided. Only the verifiable mechanic/body shop business line phone number can be utilized for this service.

Completion Checklist:

1. Complete and sign Request Form (Please print clearly)
2. Include Work Order with Request Form
3. For additional requests only please include:
 - a. Completed Request Form (including signature and current date); and
 - b. Current Work Order.

General Information:

Access codes can only be requested by authorized third parties (mechanics) while having temporary custody of the restricted driver's vehicle and not by the restricted driver themselves. The sale or use of an access code allowing a restricted driver to operate a motor vehicle without providing a breath sample on vehicle start up is prohibited by local laws and interlock program guidelines (punishments vary by state or jurisdiction). Clients should not contact Draeger US Interlock, LLC. directly, as information will not be released to them regarding access codes.

Access codes are not provided for services that are preventative maintenance, such as, oil changes, tire, brake, or battery replacements , inspections, etc. Qualified requests may be approved with a two (2) hour validity.

Please note, that access code requests will only be processed Monday through Friday between 7:00am – 7:00pm (Central Time). During those times please allow up to three (3) hours for processing. Requests submitted after 6pm (Central Time) may not be issued the same day and may be issued the next business day. Please allow extra time, if the request requires secondary state or local jurisdiction authorization (varies by state or jurisdiction).

A representative from Draeger US Interlock, LLC. will contact the mechanic directly with the access code once the provided information has been verified and the request has been approved. If an additional access code is required, and local laws and interlock program guidelines allow the issue of additional access codes, please submit a new and signed request form and check the additional request box.
